

## MY LOCAL DMV SCHOLARSHIP AGREEMENT

This Agreement is made between MyLocalDMV.org ("MyLocalDMV.org") and \_\_\_\_\_ ("Contributor").

### RECITALS

- A. MyLocalDMV.org edits, publishes and may distribute content related locations of post offices in the United States.
- B. MyLocalDMV.org intends to award one or more scholarships.
- C. Contributor has submitted content (the "Contribution") for MyLocalDMV.org to consider.

Now, therefore, the parties agree as follows:

1. The Contributor warrants and guarantees to MyLocalDMV.org that:

- (a) Contributor is 16 or older; and
- (b) Contributor is a citizen of the United States; and
- (c) Contributor must be currently enrolled as a high school or college/university student within the United States.
- (d) The Contribution is original to Contributor, except for material from copyrighted sources that is designated as such and reproduced with the written permission of the copyright holder, and does not violate or infringe any copyright or other right belonging to any third party.

2. The Contributor shall indemnify and hold MyLocalDMV.org harmless from any claims regarding the Contribution.

3. The Contribution shall become the property of MyLocalDMV.org upon submission.

Contributor does hereby sell, assign, and transfer to MyLocalDMV.org, its successors and assigns, the entire right, title and interest in and to the copyright in the Contribution and any registrations and copyright applications incorporating the Contribution, including any renewals and extensions, and in and to all works based upon, derived from, or incorporating the Contribution, and in and to all income, royalties, damages, claims and payments now or later due or payable, and in and to all causes of action, either in law or in equity, for past, present, or future infringement, and in and to all rights corresponding to the foregoing throughout the world.

4. MyLocalDMV.org shall have the right to use, exhibit, and distribute the Contributor's name, likeness, image, voice, video, and biographical information for any promotional or business purposes and in any medium which MyLocalDMV.org deems appropriate.

5. MyLocalDMV.org, in its sole discretion, will decide whether to register copyright for the Contribution in its own name and at its own expense.
6. Contributor shall receive no financial remuneration for the Contribution. The amount, timing, and number of any scholarships awarded shall be in MyLocalDMV.org's sole discretion.
7. This constitutes the entire agreement between MyLocalDMV.org and the Contributor and supersedes any other understandings or agreements.
8. Contribution does not contain or rely upon and intellectual property or trade secrets or other nonpublic technical details or business information of any kind of a third party.
8. MyLocalDMV.org may choose not to award or withdraw the Scholarship Award for any reason.
9. Contributor is not an employee of MyLocalDMV.org, an immediate family (spouse, parent, child, sibling, and their respective spouses, regardless of where they reside) of an employee of MyLocalDMV.org; or living in the same household, whether or not related, of an employee of MyLocalDMV.org.
10. The terms and conditions of this Content Contribution Agreement will be governed by the laws of the state of New York.
